Leading with quality

Federal:

- Child Care and Development Fund (CCDF)
- Head Start
- Every Student Shall Succeed Act (ESSA)

State Examples:

- QRIS as backbone for all early learning programs (Washington, Ohio)
- Elevating quality for infants-toddlers (Georgia, District of Columbia)



Embracing a systems approach

Federal Law:

- Child Care and Development Fund (CCDF)
- Head Start
- Every Student Shall Succeed Act (ESSA)

Federal Government:

- Dedicated ECE oversight for Office of Child Care and Office of Head Start;
 merged technical assistance system
- Interagency policy board (ED, HHS and others)
- Joint initiatives
- Joint policy statements and guidance

Embracing a systems approach

State Examples:

Varied approaches to organizing the work towards same outcome of aligned state approach

- Governor's Office Coordination (Illinois, Ohio)
- One executive agency coordinates with peer state agencies (Colorado, New Jersey)
- Consolidated single agency (Maryland, Oregon, Washington)

Innovation occurring as states try to move from alignment to integration

- Licensing and QRIS monitoring (Ohio)
- Licensing, QRIS, and state preschool standards alignment/integration (Washington)
- Licensing, professional development linkages (Oregon)

State-local approaches

Coordination [reduce duplication, identify gaps, information sharing]

Schools and Head Start through state coordination (Mississippi)

Coalition [formal planning/piloting around state outcomes]

- Piloting of new state initiatives (Georgia Empowerment Zones)
- Highlighting state priority on family engagement (PA Transformation Zones)

Integration [local administrative structure linked to state goals and structure]

- Hubs for planning and administering state programs (Oregon)
- Systems work and QRIS support (Colorado)

Supporting mixed delivery

Federal:

- ESSA
- Head Start

State Examples:

- Pre-k using mixed delivery (many states including New Jersey, Arkansas)
- QRIS embracing mixed delivery with alternative pathways for rating for HS and Pre-K (many states including Delaware)
- QRIS providing a single framework for all delivery "types" (child care, pre-k, Head Start) (few states, Ohio, Washington)



All parts of the system can focus on quality

Federal:

Child Care and Development Fund (CCDF)

State Examples:

- Contracts for subsidy for providers meeting higher standards, focusing on state priorities including
 - Illinois- focus on family and community engagement, linking families to other needed community services
 - Massachusetts- focus on comprehensive services
 - Indiana, Alabama, and New Mexico- embed QRIS tiering within contract structure
 - Georgia- the state is the EHS grantee. The contract for the providers allows providers to determine program eligibility for child care subsidy with families as part of the enrollment process. Providers submit the eligibility documentation to state staff who then review and confirm eligibility.

Systems + Services Support Children & Families

- The framework for our early childhood system has changed! People are actively and intentionally focusing on:
 - Whole child
 - Quality a priority
 - Children with the greatest need (and increasingly explicit on equity)
 - State & locally driven
 - Systems approach
